To be able to comment on the quality of the selection process, more transparency about the choices (pros/cons) made within the process is required.

The procedure is old fashioned (e.g. using part A / B documents) and should be automated through CECIS as mentioned in the ECA report on the UCPM response outside the EU.

Further more, some investigation could be done on making pooled transport capacities of PS a new subdomain of the EERC/Voluntary pool, and automatically cofinance transport, instead of upon request, with an annual invoice/once a year administrative process. This makes the UCPM more effective, procedures smoother, and less unnecessary.
