Resolution No. 230

43rd Session on 4 February 2016

Proposal for a Regulation of the European Parliament and of the Council amending Regulation No 562/2006 (EC) as regards the reinforcement of checks against relevant databases at external borders /Council No. 15397/15, COM(2015) 670/

Conclusions of the Resolution:

Committee for European Affairs

- 1. **takes note of** the Proposal for a Regulation of the European Parliament and of the Council amending Regulation No 562/2006 (EC) as regards the reinforcement of checks against relevant databases at external borders submitted by of the Commission and **supports** its adoption;
- 2. takes note of the Government's position to this proposal dated January 6, 2016;
- 3. **considers** however, that the Commission should iniciate introduction of the systematic controls at the EU's external borders much earlier;
- 4. **requests the Government of the Czech Republic** to inform the Committee on European Affairs as well as the Subcommittee on Migration and Asylum Policy about the progress of negotiations regarding the legislative package to improve management of the EU's external borders and their results;
- 5. **authorizes** the Chair of the Committee on European Affairs to inform the president of the Commission about the content of this resolution.
