**CONCERNING THE PRIORITIES OF THE SEIMAS OF THE REPUBLIC OF LITHUANIA
IN ACCORDANCE WITH THE COMMISSION WORK PROGRAMME 2019**

Dear Mr President,

The Seimas of the Republic of Lithuania has thoroughly examined the Communication from the Commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee of the Regions on the *Commission Work Programme 2019 – Delivering what we promised and preparing for the future* (COM(2018) 800 final) (hereinafter referred to as the Commission Work Programme).

Having considered the Commission Work Programme and assessed the envisaged new initiatives and REFIT actions, the specialised committees of the Seimas of the Republic of Lithuania have outlined relevant and highly relevant initiatives for Lithuania. After summarising the conclusions of the specialised committees of the Seimas of the Republic of Lithuania at a joint meeting on December 19, 2018, the Committee on European Affairs and the Committee on Foreign Affairs of the Seimas of the Republic of Lithuania (hereinafter referred to as the Committees) approved the priorities of the Seimas in accordance with the Commission Work Programme 2019.

The Committees are convinced that the implementation of the priorities outlined by the Seimas will contribute to a stronger, more united and democratic European Union while at the same time strengthening the security of Lithuanian citizens and delivering economic growth and jobs.

¹ After the receipt by the Seimas of an annual work programme of the European Commission, it shall be registered with the Committee on European Affairs and forwarded to the Seimas specialised committees. The specialised committees of the Seimas shall within one month from the forwarding of the annual work programme of the European Commission, deliberate on it and submit to the Committee on European Affairs and the Committee on Foreign Affairs (hereinafter referred to as the Committees) their reasoned conclusions regarding the relevance to Lithuania of the proposals presented in this programme. Taking into consideration the relevance to Lithuania of a proposal provided for in the work programme of the European Commission, the specialised committees shall assign it to one of the following three categories: highly relevant, relevant, moderately relevant. After receiving the conclusions of the specialised committees, the Committees shall summarise them at a joint meeting and communicate their joint conclusion to the Government, the specialised committees, the Permanent Representative of the Seimas to the European Union and the institutions of the European Union.
