I would like to inform you about the opinion of the Committee on European Affairs of the Chamber of Deputies of the Parliament of the Czech Republic

on the Communication from the Commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee of the Regions - Commission work programme 2025 – Moving forward together: A Bolder, Simpler, Faster Union /Council Code 5985/25, COM(2025) 45 final/.

The respective document was included in the agenda of the 55th session of the Committee on European Affairs and was scrutinized on 19th March 2025. According to the Rules of Procedure the representative of the Government Office and the Head of Representation of the European Commission in Czech Republic were present at the session to introduce the preliminary Government's Framework Position.

Communication from the Commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee of the Regions - Commission work programme 2025 – Moving forward together: A Bolder, Simpler, Faster Union /Council Code 5985/25, COM(2025) 45 final/

Conclusions of the Resolution:

Committee for European Affairs

1. **takes note of** the Communication from the Commission to the European Parliament, the Council, the European Economic and Social Committee and the Committee of the Regions - Commission work programme 2025 – Moving forward together: A Bolder, Simpler, Faster Union /Council Code 5985/25, COM(2025) 45 final/;
2. **calls on** the European Commission to actively promote the participation and involvement of national parliaments in the EU legislative process and in the actual implementation of EU policies, to take their comments and reservations on EU legislative proposals into account in real terms, to address them responsibly and not to underestimate dialogue with national parliaments overall during this term of office;
3. **would welcome** more frequent visits of Members of the European Commission to the Chamber of Deputies, which present a valuable opportunity to have a direct open discussion of specific proposals and agendas and offer the European Commission immediate feedback from the national parliament;
4. **authorizes** the chairman of the Committee on European Affairs to inform about this Resolution the President of the European Commission **in the context part of the political dialogue.**
