



## Prof. Dr Remco Nehmelman



On the 1st of October 2018, Remco Nehmelman (1971) started work as Secretary-General of the Senate of the Netherlands. Dr Nehmelman was appointed by the members of the Senate as Secretary-General of the Senate of the Netherlands on the 10th of July 2018, and he took the oath on the 2nd of October 2018.

His previous positions include a full-time appointment as full-professor of Constitutional Law at Utrecht University, in addition to the positions of assistant and Associate professor at VU Amsterdam and the University of Amsterdam and an appointment as a Senior Policy Advisor/Legislative Lawyer at the Ministry of the Interior and Kingdom Relations. From October 2018, he will remain affiliated with Utrecht University as a voluntary Professor of Public Constitutional Law.

In the period 2007–2012, he served as a consultant to the Groups of States against Corruption (GRECO) of the Council of Europe managing the transparency of funding for political parties. From June 2013 until June 2017, he was a member of the Council for Public Administration and, from April 2015 until September 2018, he was a member of the Dutch Electoral Council.
