



Dear Sir, Dear Madam:

The Congress of Deputies, the Basque Parliament, the Open Parliament Global Network (OPeN) and the Open Government Partnership (OGP) are honoured to invite you to Open Parliament Day 2025, which will be held on 6 October 2025, between 2.30 p.m. and 7 p.m., at the Basque Parliament headquarters in Vitoria. The aim is to bring together the Open Parliament community to reflect on the role that parliaments play in the fight against corruption.

Open Parliament Days have been held in recent years as part of the OGP Global Summits: in Georgia (2018), Canada (2019), Korea (2021), Estonia (2023) and Brazil (2024). These events have brought together legislative representatives, parliamentary staff and civil society organisations from various countries with the aim of sharing initiatives, actions and challenges related to the development of the global Open Parliament agenda.

During Open Parliament Day 2025, topics considered priorities by the OGP will be addressed, such as parliamentary transparency, accountability, improving effective access to public information, gender equality, the full participation of groups with special needs and persons with disabilities in decision-making, the use of digital technologies to strengthen interaction between citizens and parliamentary institutions, and the importance of consolidating a broad civic space for participation.

Open Parliament Day will also be a forum for presenting the recently approved First Open Parliament Plan of the Congress of Deputies.

The official languages of the meeting will be Spanish, Basque and English.
