Culture fosters a sense of belonging and civic engagement among citizens, which is essential for upholding our common democratic values.

They should ensure that EU strategies and funding priorities are flexible and responsive to the rapidly evolving needs of the sector as well as digital challenges and technological innovations. Without pre-empting EU budgetary negotiations we would like to stress that only with such targeted measures can we safeguard the sector's long-term resilience, competitiveness and vitality of Europe's cultural and creative ecosystem.

We look forward to continuing our joint efforts and to further strengthening Europe's role in fostering cultural diversity, creativity, and innovation.
